- our organization is required to pay our full monthly Modo invoice on time, leaving no outstanding balance longer than 45 days prior to any incident requiring access to the pool funds;
- all registered carsharers must participate in the pool; and
- the Damage Pool has no refund if our organization closes its account, if we access the pool funds in the event of an incident, or wish to switch to other options for collision insurance – e.g. the CLDI credit card coverage.

I hereby authorize Modo to charge our account the appropriate amount as of the date this form is received by Modo and on each monthly invoice thereafter, continuing to do so unless an authorized signatory from my organization terminates our business membership or requests in writing to withdraw our participation in the Damage Pool.
