Upon acceptance, Modo will, subject to all the terms and conditions in the Handbook and this Agreement,

- provide me with access to vehicles owned, leased or rented by it ("Vehicles"), and
- pay for Vehicle related expenses such as gas, tires, maintenance and pre-approved repairs.

I understand that Modo will endeavor to ensure Vehicles are clean, reliable and well maintained and will periodically inspect the Vehicles. However, I recognize that:

- carsharers share responsibility for the maintenance and safety of Vehicles;
- Modo's periodic inspection of Vehicles is supplementary to the inspection of Vehicles by carsharers;
- I will be responsible for ensuring the safe condition of any Vehicle which I drive;
- Modo does not make any representations or warranties as to the fitness or condition of any Vehicle.

I understand that Modo will ensure that Vehicles are insured under a comprehensive insurance policy, the details of which are available from Modo. I agree that Modo will only be liable to me for any damages arising out of my use of a Vehicle if Modo's gross negligence has caused the damages. I waive any right to sue or make claims against Modo and its directors, officers, employees or clients for damages arising from the fitness or condition of a Vehicle, except in cases of gross negligence. I also waive any right to sue or make claims against Modo and its directors, officers, affiliates, employees or clients for a Vehicle not being available at the time it was booked.
